## OWNER'S MANUAL

- 1. Read this manual carefully before starting assembly. Read each step completely before beginning each step.
- 2. Some smaller parts may be shipped inside larger parts. Check inside all parts and cartons before assembling or ordering parts.
- 3. Avoid scratching table tennis top and metal tube parts during the assembly process.
- 4. To make assembly as easy as possible, place all parts of the table tennis in a cleared area and remove the packaging material. Organize all parts as per parts identifier in the assembly manual. Do not dispose of the packing material until assembly is completed.
- 5. Assemble product on clean, level and flat surface.
- 6. Take time to correctly orientate parts exactly as per each assembly diagram.
- Save these instructions and your proof of purchase (receipt) in the event that the manufacturer has to be contacted for replacement parts.

### CARE AND MAINTENANCE

You have purchased a quality product that will give you years of enjoyment. By following these simple maintenance steps, you will add to the life of your new table.

#### THE TABLE TOP

The top (playing surface) of your table is made of Mid-Density Board. Like all products made of wood, it can be affected by atmospheric changes in both temperature and humidity. This may cause a slight sag or distortion as the top expands or contracts. This is normal and should not cause concern as it does not detract from the play or utility value of the table. After assembly of the table, you can minimize the effects of temperature and humidity changes by storing the table in a dry area when table is not in use.

#### STORAGE OF YOUR TABLE

This table must be stored indoors to prevent damage to the playing surface. Dampness and extreme temperature changes can cause the wood to warp, swell, crack or blister. When your table is not in use, it should be stored in a dry area. Due to the nature of particle board, table top may bow. Damp and humid conditions will amplify this. This is normal and will not affect playability of table.

#### **CLEANING YOUR TABLE**

To clean your table use a soft, damp (NOT WET) cloth only. To prevent damage to your table's playing surface, DO NOT USE ANY CHEMICALS, ABRASIVE OR CLEANING PRODUCTS on your table's playing surface.

#### MAINTENANCE OF YOUR TABLE

Be sure to oil all moving parts of your table including the pivot points. This will insure the safety and ease of use of your table.

This table must be kept indoors to prevent damage to the playing surface. Dampness and extreme temperature changes which occur on patios or similar areas can cause wood to warp, swell, crack or blister.


#### **UNLEVEL FLOORS**

If table does not seem level, it is probably due to uneven or unlevel floors. Set the table in its PLAYING POSITION and move table several inches in different directions to find the best location for the table. If the floor is extremely unlevel, table may not play or operate properly.


If table is high in the center, shim up under the outer legs.

The table has leg levelers - Adjust leg levelers as required.

# PARTS IDENTIFIER (Not to Scale)




P1 - Table Tennis Table Top Frame with Legs assembly (2 pcs)



#### STEP 1:

Lay Table Tennis Top **P1** down on a clean flat surface as shown in **FIGURE 1**. Raise **LEGS** to a vertical position and lock hinges as shown in **FIGURE 1** & **DETAIL A**.

Repeat procedure for the other P1 Table Tennis Top assembly.




#### STEP 2:

Attach one **P2** Net Post to the middle edge of where the table halves meet. Repeat this with other **P2** Net Post on opposite side as shown in **FIGURE 2**.

Then slide P3 Net into corresponding P2 Net Post and repeat for the other side.

Level table using Leg Levelers.
